**I SCOPE OF SERVICES**

- A. The Contractor shall install two 12 strand OSP single mode fiber optic cable provisioned from the nearest Central Office therefore offering communications for the Embassy Compound. Contractor is responsible for installing, terminating, testing and labeling all service provided equipment and cables within the designated embassy Compound Telephone Service Entrance Facility (CTSEF).
- B. The contract type resulting from this solicitation will be a firm-fixed price purchase order.
- C. The Contractor shall provide personnel, material, equipment, and supervision to complete the technical requirements in this Statement of Work. The Contractor shall be responsible for hiring labor and equipment vendors and shall follow security and safety protocol as directed by the U.S. Embassy.
- D. The price shall not include any duties, taxes or VAT (PDV).
- E. Any changes to the terms and conditions of this purchase order must be approved in advance in writing by Contracting Officer.
- F. Quotes must be in EUR.

**III VALUE ADDED TAX**

**IV QUALITY ASSURANCE AND SURVEILLANCE PLAN (QASP)**

This plan provides an effective method to promote satisfactory contractor performance. The QASP provides a method for the Contracting Officer's Representative (COR) to monitor Contractor performance, advise the Contractor of unsatisfactory performance, and notify the Contracting Officer of continued unsatisfactory performance. The Contractor, not the

Government, is responsible for management and quality control to meet the terms of the contract. The role of the Government is to monitor quality to ensure that contract standards are achieved.

1. SURVEILLANCE. The COR will receive and document all complaints from Government personnel regarding the services provided. If appropriate, the COR will send the complaints to the Contractor for corrective action.
  
2. STANDARD. The performance standard is that the Government receives no more than one (1) customer complaint per month. The COR shall notify the Contracting Officer of the complaints so that the Contracting Officer may take appropriate action to enforce the inspection clause (FAR 52.212.4, Contract Terms and Conditions-Commercial Items (May 2001), if any of the services exceed the standard.
  
3. PROCEDURES.
  - (a) If any Government personnel observe unacceptable services, either incomplete work or required services not being performed they should immediately contact the COR.
  - (b) The COR will complete appropriate documentation to record the complaint.
  - (c) If the COR determines the complaint is invalid, the COR will advise the complainant. The COR will retain the annotated copy of the written complaint for his/her files.
  - (d) If the COR determines the complaint is valid, the COR will inform the Contractor and give the Contractor additional time to correct the defect, if additional time is available. The COR shall determine how much time is reasonable.
  - (e) The COR shall, as a minimum, orally notify the Contractor of any valid complaints.
  - (f) If the Contractor disagrees with the complaint after investigation of the site and challenges the validity of the complaint, the Contractor will notify the COR. The COR will review the matter to determine the validity of the complaint.
  - (g) The COR will consider complaints as resolved unless notified otherwise by the complainant.
  - (h) Repeat customer complaints are not permitted for any services. If a repeat customer complaint is received for the same deficiency during the service period, the COR will contact the Contracting Officer for appropriate action under the Inspection clause.

DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

**1. BACKGROUND AND PURPOSE**

- a. The U.S. Embassy in Podgorica, Montenegro, and the Department of State's Bureau of Overseas Buildings Operations (OBO) has a requirement for contractor to install two 12 strand OSP single mode fiber optic cable provisioned from the nearest Central Office therefore offering communications for the Embassy Compound. Contractor is responsible for installing, terminating, testing and labeling all service provided equipment and cables within the designated embassy Compound Telephone Service Entrance Facility (CTSEF).

**2. GENERAL REQUIREMENTS**

- a. The Contractor shall provide personnel, material, equipment, and supervision to complete the technical requirements in this Statement of Work. The Contractor shall be responsible for hiring labor and equipment vendors and shall follow security and safety protocol as directed by the U.S. Embassy.
- b. Contractor shall provide the U.S. Embassy with a proposed schedule and a list of personnel requiring access to any property under the control of the USG.

**3. SCOPE OF WORK**

- a. Contractor will install two 12 strand OSP single mode fiber optic cable provisioned from the nearest Central Office therefore offering communications for the Embassy Compound. Contractor is responsible for installing, terminating, testing and labeling all service provided equipment and cables within the designated embassy Compound Telephone Service Entrance Facility (CTSEF).
- b. All cables must enter the CTSEF below grade from a telecom manhole installed by the US Government near the embassy compound on John Jackson Road. The US Government will be responsible for all below-grade duct bank installations into the Embassy Compound property line and into the embassy from the afore mentioned telecom manhole. In addition to the above information Contractor is to submit to DOS the addresses of the Central Offices as well as the distance between the Central Office and Embassy.
- c. A quotation should be given for the installation of 2, 12 Strand OSP single mode fiber from a secondary central office location.  
The Contractor will furnish, install, and terminate the 12-Strand OSP single mode fiber cable to a 16 port Optimux FiberMux or equivalent in the Embassy Compound Telecom Service Entrance Facility (CTSEF) room. The fiber tail assembly to be

fusion spliced onto the incoming plant fiber optic cable and fiber terminations will be of SC type (if possible) and will be factory terminated and polished. All electronic equipment must be supported by a local point-of-use uninterrupted power supply (UPS) engineered for a minimum of 30 minutes run-time

- d. Proposals shall include provision of municipal permits, a materials list and site drawings. Contractor shall provide all information and specifications of all their equipment as well as a separate cost estimate for each option.
- e. Proposal shall include delivery completion time.
- f. Proposal shall include detailed breakdown of costs.

#### **4. CONTRACT ADMINISTRATION**

- a. OBO does not make representations or warranties of whatsoever kind or nature, either expressed or implied, as to the quality, level of completion, accuracy, extent of compliance with the standards, codes and requirements described or referred to in this SOW, or the extent of coordination between or among the documents provided to the Contractor.
- b. Neither the Embassy's nor OBO's review, approval, or acceptance of, nor payment for the services required under this contract, shall be considered to operate as a waiver of any rights under this contract or any cause of action against the Contractor arising out of the performance of this contract.
- c. OBO has the right to inspect and test all services called for by the contract, to the extent practicable always and places during the term of the contract. OBO may perform quality assurance inspections (QAI) and to confirm the work is being performed according to the Statement of Work.
- d. Substantial completion of all services shall be completed by August 15, 2023.

#### **5. RESPONSIBILITY OF THE CONTRACTOR**

- a. The Contractor shall be responsible for the professional quality, technical accuracy, and the coordination of all construction and other services furnished under this contract. The Contractor shall, without additional compensation, correct or revise any errors or deficiencies in its services.
- b. The Contractor shall identify a Project Manager who shall be responsible for the overall management of this Contract. The Project Manager will be approved by the Embassy.
- c. The Contractor is responsible for safety, and shall comply with all local labor laws, regulations, customs, and practices pertaining to labor, safety, and similar matters.

Personnel are required to wear hard hats and safety vests for entrance to the US Embassy. Contractor to provide all necessary safety gear and personal protective equipment. The Contractor shall promptly report all accidents resulting in lost time, disabling, or fatal injuries to the Contracting Officer's Representative (COR). The COR will be the Leslie Taggart.

- d. All correspondence and documentations shall be in English. Montenegrin language is optional and to be only used for unofficial communication.
- e. Contractor shall submit the biodata of all employees who will work on this project 6 weeks prior to commencement of the project.
- f. The Contractor should submit vehicle information one week prior to commencement of the project to the Government.
- g. The Government retains the right to refuse entry to any person or vehicle on the embassy compound. All employees of the Contractor will be escorted by employees of the Overseas Building Operations (OBO) team or its contractor BLHI while on the job site. Any vehicle or individual seeking entrance into the Embassy compound will undergo a security screening process each time. Visitors will be issued a visitor badge for the day.
- h. Project Kick-Off Meeting will be held within 5 days of award.

## **6. DELIVERABLE SCHEDULE (CONTRACT COMPLETION):**

- a. The Contractor shall commence work under this contract promptly, execute the work diligently, and achieve final completion and acceptance, within the contract period specified.
- b. Project Completion: Furnish surplus materials, one copy of maintenance and operating information, and catalog cuts of all items installed.

## **7. SECURITY**

- a. This is an unclassified project. The work to be performed under this contract requires that the Contractor, its employees, and sub-contractors submit corporate, financial and personnel information for review by the U.S. Embassy. Information submitted by the Contractor will not be disclosed beyond the U.S. Embassy.

*Place of manufacture* means the place where an end product is assembled out of components, or otherwise made or processed from raw materials into the finished product that is to be provided to the Government. If a product is disassembled and reassembled, the place of reassembly is not the place of manufacture.

*Predecessor* means an entity that is replaced by a successor and includes any predecessors of the predecessor.

*Reasonable inquiry* has the meaning provided in the clause [52.204-25](#), Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment.

- (6) Have been voluntarily suspended. "Sensitive technology"—

*Sensitive technology—*

(1) Means hardware, software, telecommunications equipment, or any other technology that is to be used specifically—

- (i) To restrict the free flow of unbiased information in Iran; or
- (ii) To disrupt, monitor, or otherwise restrict speech of the people of Iran; and

(2) Does not include information or informational materials the export of which the President does not have the authority to regulate or prohibit pursuant to section 203(b)(3) of the International Emergency Economic Powers Act (50 U.S.C. 1702(b)(3)).

*Service-disabled veteran-owned small business concern—*

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7).
